# 2.3.2 Cabin information:

- Equipped with an Airconditioning system
- Right hand drive
- Standard Monitoring equipment with all the instrumentation to enable the driver to have a full knowledge of the operational parameters of the Van.
  Speedometer, tachometer, fuel gauge, oil pressure gauge, dual air pressure gauges, indication signal lights.
