Section 2: General Information

2.1 Purpose

The purpose of this RfQ is **for the Jetting Suction Bowser Services for Project Green.**

2.2 Scope and Terms & Conditions

The service is to be supplied in accordance with the technical specifications forming part of this RFQ.

The Contractor shall be subject to a penalty for delay of €50 per day inclusive of Saturdays, Sundays and Public Holidays for any delays over the period of performance stated above. The Contracting Authority reserves the right to terminate the contract without notice when the penalties reach a value amounting to 30% of the contract price.

2.3 Specifications

- 2.3.1 The hiring of a jetting/suction bowser complete with driver/technician on an as and when required on-call basis for the emptying of a foul water cesspit and unblocking of sewer drainpipes as necessary. The jetting/suction bowser used for the performance of these services shall be in the best possible state of repair and working condition, well maintained, of good and clean appearance, and equipped with all necessary accessories/attachments.
- 2.3.2 Emptying of foul water cesspit or water reservoir from sediment:
 - a. To empty a foul water cesspit having a depth of circa 5 meters when required. There can be the necessary to clean water reservoir from sediment.
 - b. The Contractor shall provide all the machinery, equipment and accessories necessary to carry out these services.
 - c. The Contractor shall be responsible for the emptying and disposal of the tank contents at appropriate discharge points and in accordance with environmental regulations and permits granted by the competent authority.
 - d. The Contractor shall respond to requests to empty the foul water cesspit within not more than 24 hours of the request being made by the appointed

Project Green officer in charge. e. The services shall be priced as a lump sum for each emptying service, inclusive of driver/technician, fuel, any tools and accessories, all maintenance and upkeep costs, discharging/emptying time and all time to travel to and from site.

2.3.3 **Clearing of Blockages and well cleaning:**

- a. To empty a foul water cesspit and cleaning of wells reaching circa 5 metres.
- b. Emergency Services shall be on a 24/7 on-call basis.
- c. The Services shall be carried with the use of a jetting/suction bowser to clear blockages from sewer pipes and drainage connections to toilet facilities.
- d. Emergency services shall be carried out in accordance with the following response time dependent upon the time of the request by the appointed Project Green officer in-charge.

Time for Request	Service Response Time
07:00 hrs to 16:00 hrs	Not later than 4 hours from request time
16:00 hrs to 0:00	Not later than 11:00 of the following day
0:00 hrs to 07:00	Not later than 11:00 of the same day

- f. The services shall be priced as a lump sum for each call, inclusive of driver/technician, fuel, any tools and accessories, all maintenance and upkeep costs, discharging/emptying time but EXCLUDING all time to travel to and from site.

2.4 **Execution Period**

2.4.1 The time-limit for the execution of the contract shall be twelve (12) months from the date of the Purchase Order.

Section 3 Financial Offer

3.1 **Financial Offer**

The Economic Operator shall fill-in and submit their offer by filling the Form marked as '[Financial Bid Form](#)'. The Contracting Authority reserves the right to disqualify bidders who fail to submit or provide all the requested information requested in the '[Financial Bid Form](#)'.

Economic Operators must quote all components of the price inclusive of taxes/charges, customs and import duties and any discounts BUT excluding VAT. VAT shall be paid in accordance with the current VAT regulations.

3.2 **Criteria for Award**

3.2.1 The sole award criterion will be the price. The contract will be awarded to the bidder submitting the cheapest priced offer satisfying the requested administrative and technical criteria.

The Contracting Authority reserves the right to accept or reject financial offers exceeding the estimated procurement value based on the current market rates.

The Contracting Authority reserves the right to disqualify offers received late even though they might be technically and financially compliant (please refer to the cover page of this RfQ for the respective deadlines).

Furthermore, the Contracting Authority reserves the right to refuse or cancel this RfQ, in part or in full, at its discretion without any obligation.
