Section 2: General Information

2.1 Purpose

- 2.1.1 The purpose of this RfQ is **for the Cleaning of Water Fountain at Ġnien L-Indipendenza, Birżebbuġa.**

2.2 Scope and Terms & Conditions

- 2.2.1 The services shall be provided to Project Green in accordance with the technical specifications forming part of this RFQ.
- 2.2.2 The Contractor shall be subject to a penalty for delay of €50 per day inclusive of Saturdays, Sundays and Public Holidays for any delays over the period of performance stated above. The Contracting Authority reserves the right to terminate the contract without notice when the penalties reach a value amounting to 30% of the contract price.

2.3 Specifications

- 2.3.1 The Technical specifications for this RFQ is as follows:

Task	Description	Frequency
Monitoring and Water Treatment	Monitoring of the area including respective cleaning. Chlorine tablets shall be placed in fountain top-up well and chlorine powder in each segment of the fountain.	Monitoring shall be carried out once a week. Water treatment should be carried out as necessary as long as the water is kept clear.
Cleaning	Removal of accumulated silt, sludge and sediments including any floating debris, trash and organic matter.	Once a week

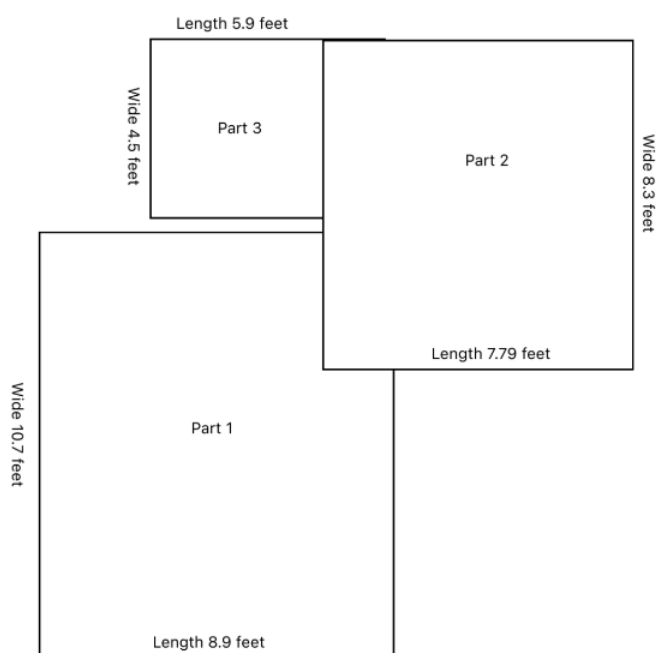
- Compliance with local environmental regulations
- Contractor must follow all applicable safety measures within the workplace area
- Availability of suitable equipment provided by the contractor
- The working hours should be between Monday and Saturday, between 8am and 6pm
- Photo evidence of works being carried out to be sent to respective contract manager.

Segmented into three parts –

Measurements of part 1: Approx. 0.7 feet depth, 8.9 feet in length and, 10.7 feet wide (Large pool)

Measurements of part 2: Approx. 0.7 feet depth, 7.79 feet in length and, 8.3 feet wide (Medium pool)

Measurements of part 3: Approx. 0.7 feet depth, 5.9 feet in length and, 4.5 feet wide (Small pool)

2.4 Execution Period

- 2.4.1 The time-limit for the execution of the contract shall be of **twelve (12) months** from the date of the Purchase Order.

3.0 **Financial Offer**

- 3.1 The Economic Operator shall fill-in and submit their offer by filling the Form marked as '[Financial Bid Form](#)'. The Contracting Authority reserves the right to disqualify bidders who fail to submit or provide all the requested information requested in the '[Financial Bid Form](#)'.

Economic Operators must quote all components of the price inclusive of taxes/charges, customs and import duties and any discounts BUT excluding VAT. VAT shall be paid in accordance with the current VAT regulations.

3.2 **Criteria for Award**

- 3.2.1 The sole award criterion will be the price. The contract will be awarded to the bidder submitting the cheapest priced offer satisfying the requested administrative and technical criteria.

The Contracting Authority reserves the right to accept or reject financial offers exceeding the estimated procurement value based on the current market rates.

The Contracting Authority reserves the right to disqualify offers received late even though they might be technically and financially compliant (please refer to the cover page of this RfQ for the respective deadlines).

Furthermore, the Contracting Authority reserves the right to refuse or cancel this RfQ, in part or in full, at its discretion without any obligation.
