Section 2: General Information

2.1 Purpose

The purpose of this RfQ is **the Leasing of Tail Lift Van for the Projects Section at Parks Management Department for a period of 90 days.**

2.2 Scope and Terms & Conditions

The service shall be provided to Project Green in accordance with the technical specifications forming part of this RfQ.

The Contractor shall be subject to a penalty for delay of €50 per day inclusive of Saturdays, Sundays and Public Holidays for any delays over the period of performance stated above. The Contracting Authority reserves the right to terminate the contract without notice when the penalties reach a value amounting to 30% of the contract price.

2.3 Specifications

- 2.3.1 Milage – less than 100,000km
- 2.3.2 Year of Manufacture – 2010 or later
- 2.3.3 Engine / Power – Engine Diesel
- 2.3.4 Body Condition – Excellent Condition
- 2.3.5 EURO Class – minimum EURO 5
- 2.3.6 Doors – minimum 4 doors
- 2.3.7 Exterior Colour – Preferably white
- 2.3.8 Make / Model – any
Seating – Capable of accommodating a minimum of 5 sitting down adult passengers
- 2.3.9 including the driver.

- 2.3.10 Configuration – right-hand drive
- 2.3.11 Transmission – manual / automatic
- 2.3.12 Tailgate – The tail gate s a tail lift which can load up to 500kg or more. The side doors can be lowered for un/loading.
- 2.3.13 Monitoring equipment with all the instrumentation to enable the driver to have a full knowledge of the operational parameters of the vehicle:
 - Speedometer
 - Tachometer
 - Fuel gauge
 - Oil pressure gauge
 - Daul air pressure gauges
 - Indication signal lights
- 2.3.14 Dimensions:
 - Length not less than 5900mm
 - Laden weight approximately 3.0 tons
- 2.3.15 Tyres – heavy duty, cut resistant, radial type, and all-weather tyres, including a spare wheel
- 2.3.16 Tow bar – A tow bar must be available including light switch and break. A third number plate must be provided.
- 2.3.17 Others:
 - Airconditioning
 - Central locking
 - Power steering
 - Hill assistant control
 - Anti-Breaking system or similar system
 - 2 side mirrors
 - Traction control
 - Seat belts
 - Mounted carrier
 - Foldable warning triangle
 - Tools required

- 2.3.18 Airbags- A minimum of four (4) airbags

2.4 Execution Period

- 2.4.1 The time-limit for the execution of the contract shall be **three (3) days** from the date of the Purchase Order.

Section 3 Financial Offer

3.1 Financial Offer

The Economic Operator shall fill-in and submit their offer by filling the Form marked as '[Financial Bid Form](#)'. The Contracting Authority reserves the right to disqualify bidders who fail to submit or provide all the requested information requested in the '[Financial Bid Form](#)'.

Economic Operators must quote all components of the price inclusive of taxes/charges, customs and import duties and any discounts BUT excluding VAT. VAT shall be paid in accordance with the current VAT regulations.

3.2 Criteria for Award

- 3.2.1 The sole award criterion will be the price. The contract will be awarded to the bidder submitting the cheapest priced offer satisfying the requested administrative and technical criteria.

The Contracting Authority reserves the right to accept or reject financial offers exceeding the estimated procurement value based on the current market rates.

The Contracting Authority reserves the right to disqualify offers received late even though they might be technically and financially compliant (please refer to the cover page of this RfQ for the respective deadlines).

Furthermore, the Contracting Authority reserves the right to refuse or cancel this RfQ, in part or in full, at its discretion without any obligation.
